- i.) Final outcome of notification of MoUD, Govt. of India.
- ii.) That the school shall comply with the provisions of DSEAR, 1973, RTE Act 2009, and direction/instruction /guidelines issued by the Department time to time.
- iii.) That the schools comply with the orders/guidelines of DOE dated 07.11.2017 and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
- iv.) That the school shall comply with the provision of Section 10 (1) read with Rule 125 of DSEAR, 1973.
- v.) That the school shall submit the latest water test report issued by Delhi Jal Board within 02 months to the District authority,
- vi.) That the school shall comply with clause 14 of order No. F.DE.15(56)/ACT/2009778 dated 11/02/2009 in r/o maintenance of DRFF. School also ensure to follow FN-21, "Accountants of India (ICAI) for proper accounting treatment.
- vii.) That the school shall make payment of salary and other admissible allowances to its teaching / non teaching staff as per ongoing CPC through bank /RTGS.
- viii.) That the school shall appoint the 2nd Special Educator in the school within 02 months and submit the requisite documents to the District authority.
