

# RULES AND REGULATIONS OF "SARV GANGA SHIKSHA SAMUII"

#### 1. MEMBERSHIP:

The membership of the society is open to any person or persons who has attained the age of majority and fulfils the terms and conditions of the society, without discrimination of the religion, caste, colours or creed by subjects to the approval of the governing body if the membership is refused to a certain person or persons the reason for refusal shall be communicated to the person concerned.

#### 3. TERMINATIONS OF MEMBERSHIP:

#### BANK ACCOUNT:

The Bank Account of the society shall be operated by the Treasurer and any one out of the secretary and president.

#### 8. GENERAL BODY:

All the member of the society will constitute the General Body.

#### 9. FUNCTIONS OF THE GENERAL BODY:

#### 12. ELECTION AND QUORUM:

The General Body in its annual meeting will elect its president and all the office bearers and members after two years by secret ballot papers. The quorum of the general body and governing body shall be 2/3<sup>rd</sup>.

#### 13. FUNCTIONS OF THE GOVERNING BODY:

- a) To arrange, finance if required from other Bank(s) institution or individual on reasonable terms and conditions and the governing body as a whole is liable for its return.
